**FEE SCHEDULE**  
EFFECTIVE JULY 1, 2026

**TARPING POLICY / PENALTY FEES**

ALL loads must be FULLY TARPED AND SECURED per Utah State Code (72-7-410 subsections 1 and 2) and South Jordan Code 7.01.050 (f). **This policy is strictly enforced.**

Uncovered loads (not fully tarped and fully secured) will be charged a PENALTY fee (see below):

- Double charge for all un-tarped loads (per charges listed below for disposal type)
- Double charge for all fees on un-tarped loads (per charges listed below for fees)
- Un-tarped loads that qualify for free disposal rate will be charged the regular rate(s) for disposal

**RECYCLING DISPOSAL**

Recycling is defined as recyclable material that Trans-Jordan currently recycles without a vendor disposal fee such as: paper, plastics, cardboard, metal, etc.

*Electronic Waste (E-Waste) and HHW are not part of this definition.*

<b>OTHER SPECIAL HANDLING FEES</b>	
Individually assessed by the Executive Director or assigned designee. ▶ <i>Examples include: Large irregular bulky items, items requiring immediate burial, carbon fiber, meth lab cleanup, etc.</i>
